SSC is pleased to inform you that we are recommending to the Office of Sustainability that your project **receive a** \$225,000 grant as requested in Phase 1 of the Campus Bike Parking Overhaul proposal. SSC would like to ensure the value of this funding is achieved by requesting that approximately 1,000 bicycle parking loops are installed with these funds. SSC reserves the right to withdraw funding if the project is deemed unsatisfactory by the full committee after estimates are obtained.

- 1. All funds must be spent by June 30, 2013.
- 2. A final report of all work completed should be provided by July 31, 2013.
- 3. Project status updates and detailed account statements must be provided at the end of each semester until the project is completed.
- 4. Any substantial modifications to project scope, budget, or timeline must first be approved by SSC.
- 5. All projects will be expected to follow campus policies and procedures as well as any applicable State and Federal laws.

## Project Description:

This project intends to replace obsolete bike parking on campus with safe and secure bike parking while adding biking amenities that will contribute to the improvement of the bicycle network on campus, which will ultimately contribute to a more sustainable future on campus at the University of Illinois at Urbana-Champaign. The goals of this project are to encourage bike parking, provide safe, secure, and convenient parking, discourage illegal bike parking, and support a sustainable and healthy campus. The funds approved for this phase (Phase 1) will replace the most deteriorated "donut-hole" bike racks in locations that are also in high demand by campus users. Future phases will ultimately eliminate the outdated and deteriorated "donut-hole" bike racks. SSC is in favor of funding Phase 1 for the full amount requested.
