




The Benefits

- Reduce dependency on coal
 - Decrease coal related pollution and carbon footprint associated with burning, transporting and mining
- Commitment to carbon neutrality
 - Decrease dependency on fossil fuels
 - Move to renewable energy sources
- Responsiveness to the student community
- Educational opportunities



Pre-Defined Project Scope



- One, two, or three utility-scale wind turbines
- Three locations selected and studied
- Grant requirements
 - At least one 1.5 MW turbine
 - On UI campus
 - Owned by the University

Available Funding

\$4.5M project budget

- Student Cleaner Energy Technologies
 Fee \$500k
- Illinois Clean Energy Community Foundation - \$2M
- U of I Utilities \$1M
- Office of the U of I Urbana-Champaign Chancellor - \$500k
- Office of the U of I President \$500k



2010 Process

- Spring Grant extended
- Fall Questions about Request for Proposal (RFP)
 - Type of electrical connection
 - Lighting requirements
 - Height restrictions
 - Cold weather package
 - Clarification of the "turn-key" option expectations
 - Maintenance contract requirements

RFP Results

- RFP
 - Issued October 27
 - Pre-proposal meeting November 12
 - Bids received November 30
- Five bids submitted
 - Twelve options submitted
 - reviewed by UI evaluation committee
 - 2011 construction schedules
 - Budget allows for only one turbine

Next Steps

- Complete Best and Final Offer negotiations
- Negotiate purchase contract
- UI Board of Trustees approval
- Address community concerns
 - Public meeting planned in January
 - Share results and answer additional questions
- Installation
 - Currently scheduled for 2011

Legal Requirements


"The University will comply with all applicable laws and regulations regarding its wind turbine project and intends to hold a public meeting about the project.

This would include the recently enacted Urbana wind turbine zoning ordinance."








Only T-3, southernmost location
