Ximing Cai (iSEE)	I support the recommendation. Since F&S is doing this and an update of the status will be helpful for the SWATeam.

John Dallesasse (Academic Senate)	I support the iWG Recommendation. In general, I support the ffort to move toward LED lighting across campus in a planned, coordinated manner. This is especially true given the connection of UIUC with the inventor of the LED, Nick Holonyak. I would not support the use of CFLs in place of LEDs.
